The hotel for the weekend will be Shephard's Beach Resort on Clearwater Beach. Each attendee is responsible for reserving a room at the hotel on their own. The hotel rates are \$99 per night for a room with two queen size beds and a pull-out couch, and \$75 per night for poolside rooms with two double beds and a pull-out couch. These rooms can comfortably sleep 4-5 people. A credit card will be required during reservation and check-in to cover all incidentals. There must be at least one person 21 or over occupying each room. For those of you who will be flying, please make arrangements to fly into **Tampa International Airport**. **Shuttle services will be provided.** Registration will be from 4:00 p.m. – 8:00 p.m. on Thursday, January 7th in the hotel lobby. It is recommended that attendees arrive at the hotel before 8:00 p.m. to ensure enough time is available for settling in before the Welcome Night begins.
